Major Activities for FY 10-11

Chair's Recognition Award	The award winners for FY 10-11: • Ashley Curry – University of Central Florida - for her professionalism, moral character, compassion and intellect essential to future leaders of the medical profession
Proposed Legislation for 2012	The Board selected the following areas for their 2012 Legislative Proposals: 1. CME 2. Medical licensure 3. Fine caps
New Legislation Enacted in 2011	<u>CS/CS/HB 7095, 3rd Engrossed/Enrolled-Prescription Drugs</u> This bill changes the regulation of activities by physicians, pain management clinics, pharmacies and wholesale drug distributors. On July 1, 2011: Practitioners, generally, will no longer be authorized to dispense Schedule II or Schedule III controlled substances. A few exceptions are provided: • Complimentary or sample controlled substances • In the health care system of the Department of Corrections • In connection with specified surgical procedures in certain timeframes • In approved clinical trials • Methadone in certain licensed treatment facilities • For patients in licensed hospice facilities Any controlled substance inventory that was acquired for dispensing that is still in the possession of a practitioner who will no longer be authorized to dispense controlled substances must be disposed of by July 11, 2011. Disposal can be achieved by either returning the drugs to the wholesale distributor or turning the inventory in to a local law enforcement agency and abandoning them. Controlled substances not disposed of by August 2 are deemed contraband and are subject to seizure by law enforcement. Beginning July 1, 2011, counterfeit-proof prescription blanks <u>must</u> be used by practitioners for prescribing of any controlled substance. The department is in the process of compiling a list of approved vendors of counterfeit-proof prescription pads (many of whom are already approved by the Agency for Health Care Administration as Medicaid vendors). This list, which will

	continue to grow as the Department approves new vendors, will be posted on the Board's website prior to July 1, 2011. You can access the Board of Medicine's website at: http://www.doh.state.fl.us/mqa/medical/. The State Health Officer, Dr. H. Frank Farmer, will declare a public health emergency concerning the possession of controlled substances for dispensing by practitioners who are no longer authorized to dispense controlled substances. The Department of Health will identify those practitioners who pose the greatest threat to the public health and those that create a risk that the controlled substances may not be disposed of in accordance with this act. Beginning on July 5, 2011, law enforcement agencies will enter the business premises of the identified dispensing practitioners and quarantine the inventory on site. The standards of practice for a controlled substance prescribing practitioner are spelled out in the law and include for each patient, among other things: • Complete medical history and physical exam • Written individualized treatment plan • Written controlled substance agreement • Regular follow-up appointments at least every 3 months Criminal and regulatory sanctions for violations of the provisions of this law are modified. Criteria for required registration as a pain management clinic are revised. Registration is required if the clinic advertises in any medium for any type of pain management services or where, in any month, a majority of patients are prescribed opioids, benzodiazepines, barbiturates, or carisoprodol for the treatment of chronic nonmalignant pain. New requirements for physicians practicing in a pain management clinic: • All physicians working in a pain management clinic must notify the applicable board within 10 days of beginning or ending practice at the clinic • All physicians working in a pain management clinic ensure compliance with facility and physical operations of the clinic, among other functions • A physician assistant or advanced registered nurse practitioner is authorized to perform the examination of a patient in a pain management clinic

	Effective January 1, 2012, each practitioner who prescribes controlled substances for the treatment of chronic nonmalignant pain must designate on his or her practitioner profile that he or she is a controlled substance prescribing practitioner. Instructions on how to update your profile will be sent prior to January 1st. <u>CS/CSHB 155 Enrolled – Privacy of Firearm Owners</u> Please go to the following web site to view the bill language: http://www.doh.state.fl.us/mqa/Legislation/legis.htm <u>CS/CS/HB 935, 1st Engrossed/Enrolled-Health Care Price Transparency</u> This bill addresses posting, in the reception area of certain medical offices, urgent care centers, and clinics, a schedule of prices charged for the 50 most common services provided to an uninsured person paying by cash, check, credit card or debit card. The bill specifies the size of the posting and parameters for its contents. A primary care provider who publishes and maintains the schedule of charges is exempt from the professional license fee requirements for a single renewal period and continuing education requirements for a single 2-year period. <u>CS/CS/CS/HB 1319 Enrolled-Certificates/Licenses/Health Care Practitioners</u> This bill authorizes the department to issue a temporary license to a health care practitioner whose spouse is stationed in Florida on active duty with the Armed Forces if the applicant meets the eligibility requirements for a full license and is qualified to take the licensure examination. It also requires the applicant for a temporary license to pay for fingerprint processing for a criminal history check in addition to the application fee. It also names the temporary certificate for practice as a physician in areas of critical need the “Rear Admiral LeRoy Collins, Jr., Temporary Certificate for Practice in Areas of Critical Need.” <i>It is also important to note that there are other bills that may affect your medical practice that were passed by the 2011 Legislature but are still awaiting Governor Scott’s signature. Those bills have not been included in this newsletter.</i>

Rule Amendments for FY 10-11

During FY 10-11, the Board drafted new rules and amended several existing rules in a continued effort to improve the quality of health care, increase patient safety, and to increase the efficiency of the Board. Some rule highlights are noted below:

Board of Medicine Rules:

Rule 64B8-1.007, FAC – Forms, Incorporated

Our forms rule continues to be updated as the Board updates various forms including the Physician Dispensing Registration, application for physician assistant prescribing, supervision data form and medical licensure applications.

Rule 64B8-3.003, FAC – Renewal Fees

During this period, the Board started the process for lowering the renewal fee from \$360 to \$342 in order to maintain enough capital to operate without a substantial surplus.

Rule 64B8-4.009, FAC – Applications

The medical licensure applications were revised for various reasons.

Rule 64B8-4.029, FAC – Registration as a Dispensing Physician; Delegation of Dispensing to Prescribing Physician Assistants

This rule was updated when the applicable form was updated. Both were updates resulting from changes in legislation that allowed medical doctors to delegation dispensing to PA's.

Rule 64B8-8.001, FAC – Disciplinary Guidelines

The Board's disciplinary guidelines were updated to provide ranges of penalties in response to new legislation that imposed new violations.

Rule 64B8-8.018, FAC – Voluntary Relinquishment of License

This rule was revised to include "obligations" as a reason for deny of a request from a physician to administratively relinquish a medical license.

Rule 64B8-9.009, FAC – Standard of Care for Office Surgery

This rule was updated to include the most current version of the American Society of Anesthesiologists for Basic Anesthesia Monitoring. This rule continues to go through the review process.

Rule 64B8-9.0092, FAC – Approval of Physician Office Accrediting

The Board received a request from the Institute of Medical Quality (IMQ) to be approved as an accrediting organization for physician offices performing surgery. IMQ was given provisional approval for one year.

Rule 64B8-9.013, FAC – Standards for the Use of Controlled Substances for the Treatment of Pain

Changes to this rule provide clarification with regard to the appropriate standards for all physicians who prescribe or dispense controlled substances (prior to HB 7095 – 2011 Legislative Session). This rule continues to undergo review.

Rule 64B8-9.0131, FAC – Training Requirements for Physicians Practicing in Pain-management Clinics (previously Standards for Physicians Practicing in Pain-management Clinics)

This rule was drafted and noticed for adoption. However, days before it was scheduled to go into effect, the Governor issued an Executive Order halting all rulemaking. After preparation of an extensive Statement of Estimated Regulatory Costs, the rule was then sent to the 2011 Legislature for ratification. The rule was not ratified. HB 7095, effective July 1, 2011, removed the Board's rulemaking authority in all areas related to pain-management clinics except for training requirements. The training requirements rule continues to go through the review process.

Rule 64B8-9.0132, FAC – Registration/Inspection or Accreditation of Pain-management Clinics

This rule was drafted and noticed for adoption. However, days before it was scheduled to go into effect, the Governor issued an Executive Order halting all rulemaking. After preparation of an extensive Statement of Estimated Regulatory Costs, the rule was then sent to the 2011 Legislature for ratification. The rule was not ratified. HB 7095, effective July 1, 2011, removed the Board's rulemaking authority in all areas related to pain-management clinics except for training requirements. This rule will not go forward.

Rule 64B8-9.0133, FAC – Approval of National Organizations that Accredite Pain-management Clinics

This rule was drafted and noticed for adoption. However, days before it was scheduled to go into effect, the Governor issued an Executive Order halting all rulemaking. After preparation of an extensive Statement of Estimated Regulatory Costs, the rule was then sent to the 2011 Legislature for ratification. The rule was not ratified. HB 7095, effective July 1, 2011, removed the Board's rulemaking authority in all areas related to pain-management clinics except for training requirements. The rule continues to go through the review process.

Rule 64B8-9.0134, FAC – Maximum Number of Controlled Substance Scripts Written at a Pain-management Clinic during a 24-hour Period

This rule was drafted and noticed for adoption. However, days before it was scheduled to go into effect, the Governor issued an Executive Order halting all rulemaking. After preparation of an extensive Statement of Estimated Regulatory Costs, the rule was then sent to the 2011 Legislature for ratification. The rule was not ratified. HB 7095, effective July 1, 2011, removed the Board's rulemaking authority in all areas related to pain-management clinics except for training requirements. The rule will not go forward.

Rule 64B8-11.001, FAC – Advertising

The Board received a request from the American Board of Interventional Pain Physicians to be recognized for the purpose of advertising. This request was approved by the Board.

Physician Assistant Rules:

Rule 64B8-30.003, FAC – Physician Assistant Licensure

This rule was amended to incorporate the various PA forms into the applicable rule. These forms include the Supervision Data Form, the Prescribing Physician Assistant application and the application for Changes to the Prescribing License. The rule also includes changes to the forms related to new legislation which allows physicians to delegate certain dispensing duties to PAs.

Rule 64B8-30.019, FAC – Fees Regarding Physician Assistants

This rule was modified to incorporate the reduction in renewal fee to \$275.00.

Office Surgery Registration and Inspection Program Rules (Department)

Rule 64B-4.003, FAC – Office Surgery Registration Requirements, Fees (Department Rule)

This rule was modified to incorporate the registration application into the rule by reference.

Pain Management Clinic Registration and Inspection Program Rules (Department)

Rule 64B-4.006, FAC – Pain-management Clinic Fees (Department Rule)

This rule was modified to clarify the registration fees for pain-management clinics include initial registration fees, physical change of location and change of ownership.

Rule 64B-7.001, FAC – Pain-management Clinic Registration Requirements (Department Rule)

This rule incorporates the registration application by reference in the applicable rule. Changes were also made to the registration as a result of SB 2272 (2010 Legislative Session) and starting work on revisions to the application as a result of HB 7095 (2011 Legislative Session).

Rule 64B-7.002, FAC – Disciplinary Guidelines (Department Rule)

This rule sets forth the disciplinary guidelines related to pain-management clinic violations.

Rule 64B-7.003, FAC – Counterfeit-resistant Prescription Blanks (Department Rule)

This rule, resulting from SB 2272, is still in progress. It was tolled to develop a Statement of Estimated Regulatory Costs.

Board, Committee and Regulatory Meetings FY 10-11

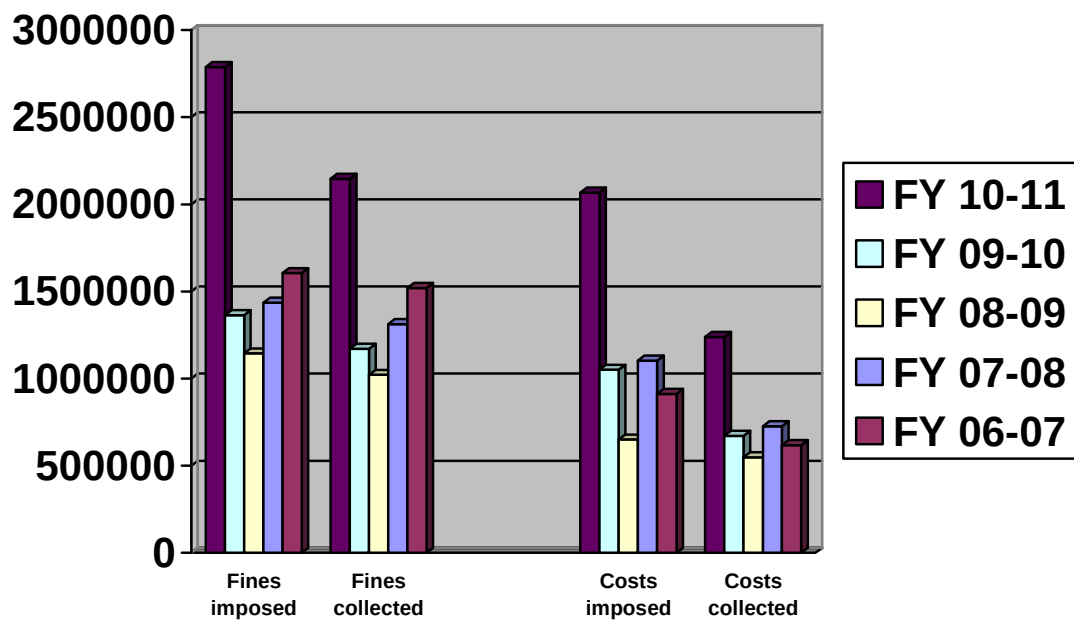
